There are no geographic restrictions; clients come from the entire OH/KY/IN tristate area. As of 12/31/24. more than 2500 pet families were enrolled. Services include basic wellness and preventative services; acute sick care; treatment of chronic conditions such as diabetes or renal failure; monthly flea and heartworm prevention; and compassionate end-of-life care. Services are highly subsidized but not free.

4b (Code:) (Expenses \$ 248,723. including grants of \$) (Revenue \$ 183,221.) Affordable Surgical and Dental Services: The clinic's Advanced Care Center provides routine spay/neuter and other surgical procedures such as mass removals, enucleations, and hernia repairs. Dental services include routine prophylaxis; and extractions. Treatment for heartworm disease is also provided.
